SE SW Awards Panel TOR Document

Name:

The group shall be known as the Swim England South West Awards Panel

Purpose

The purpose of the panel is to be responsible for the judging of the annual Swim England South West Awards which link to the Swim England Awards.

Membership of the panel:

Membership of the panel will consist of, The Regional President, The Regional Staff lead for the Awards, A Regional Board Rep, the Lead Volunteer for the Awards, and Members of the Regional Youth Panel.

The panel will have the right to co -opt additional members as necessary to ensure a fair and unbiased process.

Panel meetings will be convened by the regional staff lead.

Any conflicts of interest must be declared by each panel member who will then be exempt from discussion involving that particular nomination or award category.

Aims

- 1. To ensure that nominations for regional awards are considered against specific criteria in a fair and unbiased way.
- 2. To agree regional award placings on an annual basis

Objectives:

- 1. To receive and consider the nominations for the Regional Awards.
- 2. To identify regional winners from the nominations received
- 3. To ensure that all winners are selected based on the information within the nomination in a fair and transparent manner

Meetings:

A minimum of one meeting will be held per year, (with a presumption of an online meeting) the meeting will be arranged by the regional staff lead as agreed by panel members.

When possible, documentation for the meeting will be sent out in advance of the meeting date.

Decisions will be recorded and kept confidentially

Responsibilities:

The panel will be responsible for:

- 1. Deciding the placings for each category as appropriate
- 2. Maintaining complete confidentiality on all discussion that take place within the panel meetings and outside of the meetings.
- 3. Withhold any announcements of awards winners until such time after they are announced by the region.
- 4. Ensure that regional winners are forwarded to Swim England by the required date.

Reporting:

The regional staff lead will forward details of award winners to Swim England and will report on the work of the panel to the board.

Policies:

All panel members must adhere to Swim England and Swim England South West Policies and procedures.

Panel members may have access to confidential information. Confidential information must not be shared or discussed outside of the meeting.
