124 Club Development

- 124.1 SwimMark / Club Affiliation
 - 124.1.1 All clubs managed to meet the deadlines for accreditation purposes.
 - 124.1.2 This was not managed without problems: OMS issues, incorrect level of DBS, etc
 - Many clubs do not follow their constitution when holding an AGM or when following other procedures and processes.
- 124.2 Safeguarding
 - 124.2.1 Still problems with people booking more than one date and also failing to turn up for their workshops. Proposal to start charging all participants £5 per person which can be managed through Paypal and then booking will be returned to Survey Monkey.
 - 124.2.2 Propose to upgrade Survey Monkey to allow 3 / 4 devices to be linked to it at any one time. Agreed unanimously.
- 124.3 Inclusion
 - 124.3.1 The Swimming Committee have agreed that officials at Regional competitions may wear black or white skirts or trousers.
 - 124.3.2 Welfare Officers are not happy with the wording on guidance for the use of period wear. This has been referred back to inclusion at SE for redrafting of wording going forward.
 - 124.3.3 It has come to our attention that the terminology used by announcers at swimming competitions needs to be made gender neutral. Not 'ladies / girls / boys / men clear the water' it should be 'swimmers clear the water please'
