<sup>1</sup> Independent as per the Sport England A Code For Sports Governance definition: "a person is independent if they are free from any close connection to the organisation and if, from the perspective of an objective outsider, they would be viewed as independent. A person may still be deemed to be 'independent' even if they are a member of the organisation and/or play the sport. Examples of a 'close connection' include:

(A) they are or have within the last four years been actively involved in the organisation's affairs, e.g. as a representative of a specific interest group within the organisation such as a sporting discipline, a region or a home country;  
(B) they are or have within the last four years been an employee of the organisation; or  
(C) they have close family ties with any of the organisation's directors or senior employees"
